**12 x 13.5 stable: \$200** – All stables have concrete floors and electrical outlets. You may want to bring additional lighting.

**Booth purchases are by check, made payable to Community Events at StoneCreek.** Send your check to Community Events at StoneCreek at P.O. Box 130, Cotter, AR 72626. **Or you may request a PayPal invoice.**

The event will occur rain or shine. Last day to cancel with refund: February 31, 2024.

Vendors must have merchandise on site available for purchase.

Food trucks will be on site.

**Set up**

Friday, April 5, 10 – 6 p.m.

The indoor venue will be locked and is secure, so you can feel safe leaving your merchandise in your indoor booth Friday night. If you want to leave your booth early, please have a padlock for your stable door.

Outdoor booths are not secure, and there will be festival-goers in the area until 8 pm. We are not responsible for damages or losses, and recommend that you not leave high-value items.

**Takedown**

You are welcome to tear down your booth whenever you are ready to leave. Or on Monday morning if you are in a stable.

**Refunds**

The last day to cancel with a refund is February 29, 2024. No refunds unless we are able to fill your space.
